The acceptance of tender will be subject to the following conditions:

- 1. K-DISC reserves the right of accepting or rejecting any or all the tender without specifying any reason(s) thereof.
- 2. No tender will be considered unless rates are quoted for both parts (Part A-AMC & Part B rates for the supply & replacement of defective batteries).
- 3. Corrigendum if any with related to the tender will be published in K-DISC website.
- 4. Bidder must furnish necessary Authorization certificate from OEM & experience details in handling similar kind of works to participate in particular bid
- 5. The successful tenderer must repair / supply/install the products immediately after acceptance of order.
- 6. Withdrawal from the tender procedure after its acceptance or failure to supply/repair within a specified time will entail cancellation of the order.
- 7. No representation for enhancement of rates, once accepted, will be considered
- 8. The rates quoted should be inclusive of buy back rate, transportation, installation charges, taxes etc.
- 9. Payments will be made only after the supply/repairs and installation are actually verified and also subject to allotment of funds. Invoices submitted must be in the name of K-DISC HQ office, Vazhuthacaud, Thiruvananthapuram. Payment will be released on certification from concerned engineer in charge.
- 10. AMC will start from the date of successful installation & handing over of UPS & batteries. AMC payment will be on quarterly basis & shall be distributed between the 4th, 7th,10th and 13th month of the year upon receipt of invoice.
- 11. Under no circumstances, shall the successful firm sublet the contract. If it is found that the contractor has violated the conditions or the service rendered is substandard, the contract will be terminated without any notice by K-DISC.
- 12. Risk purchase clause: K-DISC reserves the right to terminate the contract if found unsatisfactory at any stage of work without assigning any reasons and have the right to make alternative arrangements to carry out the work at the default contractors risk.
- 13. In case of any dispute arising at any point of time during pre and post bidding process, the decision of K-DISC will be final and binding.
- 14. Bidder should go through the tender document carefully to understand the terms, conditions & documents required to be submitted as part of the bid.
- 15. Any complaint should be attended within four hours of registration and should be finished on the same day itself. For major complaints or for extension of time, prior permission will be required from K-DISC. Standby facility should be provided in any case if the issue is not resolved within 24 hours.
- 16. LD clause: An amount of Rs.250/- (Rupees Two Hundred and Fifty only) per day or part thereof up to maximum of Rs.2000/- (Rupees Two Thousand only) will be deducted from the payment due If the issue has not been rectified within a downtime of 48 hours from the date of registration of complaint.
- 17. The agreement will be entered into between K-DISC and with the agency, initially, for one year and may be extended at the sole discretion of K-DISC.

- 18. If any parts are to be replaced, it should be of the same version or a higher version of similar make and quality.
- 19. The agency shall have sufficient financial and manpower strength to execute, comply and maintain the work in accordance with the contract to the complete satisfaction of K-DISC.
- 20. In case of default on the part of the agency in carrying out any order. K-DISC shall be entitled to get the work done by any other person and the expense met will be deducted from the payment due to the AMC provider.
- 21. Delivery location: KDISC-KKEM office, lower basement floor (-1), Carmel Towers building, Vazhuthacaud, Thiruvananthapuram
- 22. Method of Selection: Least Cost System (LCS) -After evaluation of technical & financial bids, L1 bidder will be selected.
- 23. The successful agency will have to execute an agreement with K-DISC HQ on a Non-Judicial Stamp Paper worth Rs.200/- (Rupees two hundred only). All the terms and conditions, scope of work etc. contained in the tender document shall form part of the agreement.
