TERMS AND CONDITIONS

1. The Tender offers, duly filled, shall be submitted in a sealed envelope and shall be super scribed "K-DISC - Hiring of a Car on Monthly Basis", in the enclosed proforma (Technical Bid and Financial Bid shall be submitted in separate envelopes)
2. The tender should be duly sealed and addressed to the Executive Director (Management Service), K-DISC, 4th floor, India Heights Building, Govt.

Women's College Road, Vazhuthacaud, Thycaud P.O.

3. The bids will be opened on 16/07/2025 at 3.00 PM in the Kerala Development and Innovation Strategic Council (K-DISC) by the Tender Committee constituted for the purpose.
4. The contract will be valid for a period of one year from the date of signing of agreement during July 2025 and extendable further for another one year.
5. There will not be any ceiling on running distance in Km on day-to-day basis, but the minimum during a month will be 3000 Kms. In case of usage less than 3000 Kms, the remaining Kilometers will be carried over to the succeeding month/months up to the end of the contract period. In case of usage more than 3000 Kms, a negotiable rate as per contract will be given.
6. Kerala Development and Innovation Strategic Council (K-DISC) shall be liable to pay the lease rent (dry lease) on monthly basis as per the agreement only after making statutory deductions. In case of the vehicle without driver and fuel, the service provider has to bear the expenditure on repair and maintenance of vehicle, insurance, oil, toll, road tax, RTO charges, registration charges, other incidental expenses etc.
7. Agreed rate as per agreement will not be revised during the agreement period.
8. If the vehicle provided is not found satisfactory, the same will be returned for immediate replacement. If no replacement is provided in time, Kerala Development and Innovation Strategic Council (K-DISC) would have a right to hire another vehicle and the additional cost incurred in this regard will be borne by the service provider.
9. Generally, vehicle will be utilized into 24 X 7 manner on all calendar days.
10. The vehicle should have valid registration, insurance and PUC certificates, etc. The service provider should produce the original certificates for verification and a copy of them at the time of signing the agreement.
11. The service provider should have telephone/ contact numbers round the clock.
12. A daily record of time to time and mileage shall be maintained in a log book on daily basis.
13. In case of breakdown during official duty, it shall be the responsibility of the service provider to provide a substitute vehicle immediately. In case, the substitute vehicle does not report on time/does not report at all, Kerala Development and Innovation Strategic Council (K-DISC) would have the right to hire another vehicle and the additional cost incurred on this account will be borne by the service provider and will be deducted from the monthly lease rent due to the service provider/contractor.
14. In case of failure of the service provider in providing/making available of vehicle on account of any defect/ fault/ breakdown/ not reporting or alternative arrangement with prior permission shall be made in time. Kerala Development and Innovation Strategic Council (K-DISC) would have the right to cancel the agreement at any time if the service provider/contractor commits failure on providing services for second time within the contract period.
15. The billing will be done on monthly basis. GST generated bills of the month should be submitted to this office in the 1st week of the next month.
16. In case of any dispute of any kind and in any respect whatsoever, the decision of the Kerala Development and Innovation Strategic Council (K-DISC) shall be final and binding on the service provider.
17. If any of the terms & conditions (1) to (16) above is not found fulfilled during the period of agreement, Kerala Development and Innovation Strategic Council (K-DISC) reserve the right to discontinue the contract without assigning any reason thereof.
18. TDS and other Taxes shall be deducted as per statutory compliance from the lease rent payable to the service provider.
19. K-DISC reserves the right to negotiate with the successful bidder and to cancel the notice and process at any stage.
