3. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the contractual delivery period.
4. The item shall be delivered to the following address: “The Procurement Manager, Kerala Development and Innovation Strategic Council (K-DISC), India Heights Building, Govt Women’s College Road, Vazhuthacadu, Thycadu P O, Thiruvananthapuram, Kerala”
5. 100% payment will be made on the signed bill submitted in the name of the Member Secretary, K-DISC after inspection and acceptance of the material.
6. Any transit damage/loss of material shall be covered by the supplier with proper replacement or insurance coverage provided by the supplier.
7. In case the supplier fails to deliver the material within the stipulated time or supplies material not meeting the required specifications, the purchaser reserves the right to procure the material from alternate sources at the risk and cost of the defaulting supplier. Any additional expenditure incurred by the purchaser in this regard shall be recovered from the supplier.
8. Any dispute arising in relation to this quotation and subsequent purchase order/contract shall be subject to the jurisdiction of the courts at Thiruvananthapuram, Kerala.
9. In the event of any dispute or difference arising out of or in connection with this quotation or subsequent purchase order/contract, the same shall be referred to arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996, as amended from time to time. The seat of arbitration shall be Thiruvananthapuram, Kerala, and the language of the proceedings shall be English.
